### Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Stakeholders included were administration, certificated and classified employees, student services, parents, as well as conversations with scholars. Based on the surveys and meetings the priorities included adding additional instructional days to the school year, offer summer school, extend instructional time, and increase social-emotional learning. These priorities will expand learning opportunities for all scholars. Ongoing collaboration with administration, staff, and student services will continue during monthly meetings to analyze the results of what is being implemented and make adjustments as needed. Administration will continue to update the school board on the progress that is being made.

A description of how students will be identified and the needs of students will be assessed.

Scholars will be identified and the needs of scholars assessed will be done with our quarterly assessment plan and our MTSS process. Our school will utilize assessments such as iReady, IXL, Benchmarks, summative and formative assessments, NWEA, ESGI, DRA, Writing, etc. Mental health assessments will also be provided to identify SEL and other areas of support that creates barriers to student learning. Assessments will be given quarterly to identify progress, effectiveness of supports, and additional areas of needs.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

The EOL grant will be posted on the school's website and communicated to staff, and meeting with families with Coffee with the Principal. As these programs continue throughout the school year administration will collaborate with staff and provide newsletters to families monthly on the progress being made. Teachers will also communicate to families through weekly newsletters, scheduled conferences and weekly phone calls.

A description of the LEA's plan to provide supplemental instruction and support.

DTPA will provide supplemental instruction and support by extending the school year, offering extended instructional time, and increasing student support services. We will offer a summer learning program in 2021 and 2022. The supplemental instruction will include academic support and social-emotional learning.

DTPA will use grant funds by adding additional paraprofessionals for small group instruction to help close learning loss at all grade levels. We will also use grant funds to provide additional academic services, assessments, analyzing data, and purchasing additional curriculum and intervention materials to support the extended instructional time we are providing.

DTPA will increase its support services in counseling, behavior intervention, social emotional learning, student trauma, and family support services.

Lastly, DTPA will provide additional PD for all staff members on strategies of how to address scholars and families academic needs and social-emotional health.

The Expanded Learning Grant Funds will primarily be budgeted for extended learning by adding extended days to the calendar, adding extended hours to the school day, summer learning programs, small group instruction to help close the achievement gap, and additional counseling, PD, curriculum, and assessments for social-emotional learning. The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. ## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
